Facility is open Monday-Friday 8:00 AM-3:30 PM and Saturday 8:00 AM-11:30 AM

Prohibited dumping of the following wastes:

- Unrinsed pesticide containers
- Lead acid batteries
- Waste oil
- Sludge
- Manure
- Septic tank pumpings
- Infectious wastes
- Ignitables (solvents, paints, fuel)
- Corrosives (acids, alkaline, reactives)

Note:

Paints and other hazardous wastes in original containers may be brought to the Sanitation Department for disposal.

Re-Use Room is open to the public and may have paints, stains, and other unused items – call the Sanitation department for details.

Used oil and antifreeze will be accepted at the Sanitation Office. The Sanitation office will provide directions on disposal of motor oil at the Sanitation department site.

Asbestos disposal requires manifest.

All loads not properly secured or tarped are charged double the tipping fee. Random waste screening is practiced at this site; you will be required to participate. While at the facility all children and pets must remain inside vehicle.

Yard Waste such as grass, leaves, trees, and shrubs can be dropped off at the city yard waste site located at the Sanitation Department.

Note:

High intensity discharge lights include Mercury Vapor, Metal Halide and High-Pressure Sodium lamps.

Mercury products include mercury switches, thermometers, relays, thermocouples, thermostats, mercury spill kits, and liquid mercury. *Loose mercury must be in containers of no more than 1 pound.*

Electronic scrap includes CRT monitors of any size, wood console TV, projection TV, flat screen (LCD or plasma) of any size, and *mechanical e-waste*.

Mechanical E-Waste includes items with moving cogs/gears/servo motors such as printers, copy machines, fax machines, scanners, keyboards, mouse, or CPU computer unit (the computer unit by itself with all internal parts such as motherboards, processors, sound/video/expansion cards, disk drives, and power supplies.

Appliances are charged per appliance (*Recycle North Dakota* accepts washers, dryers, stoves, and microwaves ONLY)

No Freon charged items accepted.

Plastic grocery bags with a recycling symbol can be taken to Walmart or Hugo's.
